I UNDERSTAND THAT I OR MY CHILD CAN BE EXCLUDED FROM FUTURE PARTICIPATION IF THESE GUIDELINES ARE NOT FOLLOWED.

I understand that priority for participation in this Program is given to returning players, higher grade levels, parish members, and the order in which in person individual registrations are received, in that order; some students may have to play at a higher grade level; and whether a team is available at any level depends on the availability of coaches and other volunteers for that team.

I am giving my permission to use photographs of my child at practice or in games in promotional materials for STM School and Parish.

The STM Parish Basketball program and its representatives have permission to have my child treated by a medical professional in my absence should they deem that necessary. I understand that in an emergency my child will be taken to Children's Healthcare of Atlanta at Egleston.

I assume all risks and hazards incidental to such participation and hereby waive, release, absolve, indemnify and agree to hold harmless St. Thomas More and the directors, supervisors, coaches and other participants in Parish Basketball, for any claim arising from injury or illness which may directly or indirectly result from my child's participation in STM Parish Basketball activities.
